Description



Paralegals assist lawyers in preparing cases. They also carry out administrative functions, and may on occasion undertake preliminary legal research work, under the supervision of a lawyer. This program will help students discover the challenges offered by a career as a paralegal. It will also provide them with more than just legal facts and theories. Indeed, students will have the opportunity to study substantive, procedural, and paralegal skills courses.

Program Admission Requirements

Possess grade 12 education or its equivalent (i.e. secondary school graduation) or mature

student status (19 years of age or over), OR

- Possess previous post-secondary education (diploma or degree), and
- Satisfy the English language proficiency requirements by either: •
- Proof of a minimum of three years of formal secondary school education in English 0 language and a good command of the English Language (both orally and in writing),
- IELTS score of 6.0 0
- 0 TOEFL 550 score
- Any other English language assessment test with equivalent score 0
- College's admission test with a minimum score of 60% 0

Those not meeting the standardized test (IELTS or TOEFL) cut-off mark may be required to take the three-month ESL offered by the College.
